#### PSO meeting 9 July at 10 am

We are delighted to announce our speaker for the meeting is Jo Fowler, the Regional Safeguarding Lead for East Anglia within the National Safeguarding Team. Jo joined us after a long career in the Probation Service six months ago. Her role focuses on enhancing safeguarding practices across the region by supervising diocesan and cathedral safeguarding officers, supporting the implementation of national standards, and helping Church bodies respond to audit findings. #### Safeguarding Referrals - Imminent Threat

Recently, several referrals have been made to the duty phone regarding situations that posed an imminent threat to church staff and the congregation. In cases of safeguarding emergencies, the police must be contacted immediately via 999.

Two incidents have been reported involving individuals either possessing or claiming to possess a firearm. Both cases presented a direct and imminent danger to church staff and the congregation—circumstances in which contacting the police via 999 was necessary.

When an incident of such a nature is reported to the Police the caller will be provided with an incident number that should be added to the log of concern and then referred into the Diocesan Safeguarding team via the process outlined below.

 When making a referral by calling the Safeguarding Duty Message Service, please leave a message with your name, telephone number and a brief explanation of the reason for your call.



The team member on duty will be alerted to your message and will call you back to discuss your safeguarding referral, offering professional advice and support and together with you agree a plan to manage the next steps.

 In a safeguarding emergency please contact the Police on 999

Out of hours: To report a safeguarding concern when the Diocesan Office is closed, or when Diocesan Safeguarding Team members are unavailable, you can call the Safeguarding Duty Telephone Number: 01353 652747, which will forward your call to our partners at the '<u>thirtyone:eight</u>' Helpline. Let them know that you are calling from the Diocese of Ely. (Please note that the Helpline is not available between Midnight and 7.00am.)

All emergency and non emergency concerns and allegations must be recorded and discussed with the DSA within 24 hours of receiving the information or as soon as the information becomes known and not left until the end of the day. The Safeguarding Team transfer the duty phone over to Thirtyone:eight at 5pm when they are due to finish work.

Slow reporting could lead to increased risk for the parties involved.
